Day 1	The ninth Electricity Transmission Stakeholder Group meeting began with a welcome from the Chair, Trisha McAuley. The agenda covered the priority relating to Transparency and then focused on Stakeholder Engagement, Price Control Deliverables and Output Delivery Incentives.
	On Transparency, the Stakeholder Group provided feedback on what was contained in the July iteration of the business plan. The Group agreed that this area needed considerably more work and laid down a series of challenges to NGET.
	On Stakeholder Engagement, NGET provided an overview of activities to date and steps being taken to address any outstanding gaps. NGET was challenged to ensure it had in place a Stakeholder Engagement Strategy which aligned with the Ofgem principles.
	Finally, there was extensive discussion, and a series of challenges raised, on the Price Controls Deliverables and Output Delivery Incentives.
